For the 2022 Community Health Needs Assessment (CHNA), the hospital has defined their community to be the geographical area of Collin, Dallas, Ellis, Henderson, Hunt, Kaufman, Navarro, Rockwall, Tarrant, and Van Zandt counties. The community served was based on the contiguous ZIP codes within the associated counties that made up nearly 80% of the hospital facilities' inpatient admissions over the 12-month period of FY20.
