

SUMMARY ANNUAL REPORT

For BAYLOR SCOTT & WHITE HEALTH AND WELFARE BENEFITS PLAN

This is a summary of the annual report of the BAYLOR SCOTT & WHITE HEALTH AND WELFARE BENEFITS PLAN, EIN 46-3130985, Plan No. 508, for period 01/01/2018 through 12/31/2018. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BAYLOR SCOTT & WHITE HOLDINGS has committed itself to pay certain self-funded Medical claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with METROPOLITAN LIFE INSURANCE COMPANY, NATIONAL GUARDIAN LIFE INSURANCE COMPANY, HYATT LEGAL PLANS, INC. to pay Dental, Vision and Legal claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2018 were \$22,628,814.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$-12,737,000 as of 12/31/2018, compared to \$-702,000 as of 01/01/2018. During the plan year the plan experienced a decrease in its net assets of \$-12,035,000. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$456,151,000 including employer contributions of \$279,873,000, employee contributions of \$172,992,000, and other income of \$2,927,000.

Plan expenses were \$468,186,000. These expenses included \$42,487,000 in administrative expenses, and \$425,699,000 in benefits paid to participants and beneficiaries.
